- Any failure by a property owner to pay Township real estate taxes by December 31 of the year in
 which they are due on a LERTA parcel shall result in immediate removal of the parcel from the
 LERTA program. An interim tax bill at the full assessed value shall be issued in accordance with
 the LERTA Ordinance.
