EAST MANCHESTER TOWNSHIP BOARD OF SUPERVISORS FEBRUARY 8, 2011

Present: Chairman Steven H. Gross, Jr., Vice-Chairman David L. Naylor, Supervisor Barry E. Rudisill, Attorney Christian Miller, Engineer Byron Trout, Secretary/Treasurer/Public Works Director Dave Gentzler, and Zoning & Codes Enforcement Officer Katrina Rife

At a regular meeting held at the township building, Steven H. Gross, Jr. called the meeting to order at 7:02pm.

The Pledge of Allegiance was given to the Flag of the United States of America.

Steven H. Gross, Jr. disclosed that since the 1/11/11 meeting, the Board met on 2/2/11 for personnel policy and to meet with council regarding employment issues.

The minutes of 1/11/11 were accepted per motion from David L. Naylor with a correction under the Rumsey item being Dave Gentzler, not Steven H. Gross, Jr. who was along on site visit. Motion seconded by Barry E. Rudisill and carried unanimously.

Public Comment

Bill Marks of Apple Tree Lane commented on the snow removal from sidewalks in Sherman Oaks. Most of the residents comply with the 24-hour, but many did not know. He suggests at the beginning of the season, some sort of communication be handed out informing them of the rules. He volunteered to cover Sherman Oaks. Also, if cars were not parked on streets, the snow plow could do a much better job – is there any way to have them moved? Discussion continued on methods of communication and a suggested time of Fall for the notice to which street sweeping information could also be given.

Ann Marks mentioned that she was able to get an answer on the Codorus Creek bridge street repair from County Commissioners and it should be started beginning of March. Keith Gillespie took 6 weeks to get back to her.

Special Request

Brad Rentzel, representing the Zoning Hearing Board would like consideration a of Zoning Ordinance Amendment regarding Electronic Reader Boards for Advertising. They have had difficulty since there is nothing in the ordinance on LED signs. Interpretation for these signs has come to them 3 different times last year. Steven H. Gross, Jr. asked for suggestions. Barry E. Rudisill commented that other municipalities be contacted for what they have.

Joel mentioned the sign at Otterbein has been a problem with the intensity.

Solicitor will bring back sample ordinance next month.

Solicitor's Report – Attorney Andrew Miller

- Intermunicipal Agreement Township's final comments sent to Stacy MacNeal and she is circulating around. Already authorized to advertise, no further action needed.
- Rentzel Heights agreement have final form, although there is something Stacey said they would like to change. Attorney Andrew Miller advised to sign and show that Township is moving forward on what was agreed upon. If they do not sign they will have to come back. Dave Gentzler spoke with them today and mentioned it should be discussed in Executive session.

Engineer's Report – Byron Trout

- Orchard Business Park lot 10,11, & 12 as-builts reviewed and are adequate.
- Surety reductions:
 - Orchard Business Park lot 10 in the amount of \$369,396.12 with \$117,711.22 remaining per motion by Barry E. Rudisill, seconded by David L. Naylor and carried unanimously. Byron Trout will check on water that empties onto property along Canal Road; neighbors still have some concern as expressed to Steven H. Gross, Jr. PennDOT requirements on the road widening for Canal Road are an issue with the HOP they want both sides widened.
 - Chestnut Valley phase 2 completed, reduction in the amount of \$31,393.77 per motion by Barry E. Rudisill, seconded by Steven H. Gross, Jr. and carried 2 –1 vote; David L. Naylor opposed. Wearing course was discussed.
 - Chestnut Valley phase 3A in the amount of \$6,599.51 with \$55,039.10 remaining as per motion by Steven H. Gross, Jr., seconded by David L. Naylor and carried unanimously. Getting Board Road completed is a priority. Barry E. Rudisill commented that the township has put up with long enough and is isn't fair to the residents on Board Road. Byron Trout added that gas cuts would be expected. Dave Gentzler would like to negotiate to get 12mm asphalt (Superpave) and hold-off on complete top. Byron Trout added that the plan is under the old specs as IB2A.

Gross, Jr. to ratify <u>Resolution 2010-8</u> was seconded by Barry E. Rudisill. David L. Naylor recused himself as an employee of Met Ed. Motion carried.

- Northeastern York County Sewer Authority refund. Katrina Rife has complete her part. Dave Gentzler and Byron Trout need to do their final.

- When do new recycle containers materialize? Dave Gentzler asked Judy today – it is expected to be about 1 month. We have about 500 in stock. Discussion on discounted rate. A motion by David L. Naylor, seconded by Steven H. Gross, Jr. to reduce the cost of existing recycle bins to \$5.00.
