ALL TAXES ISSUED BEFORE SEPTEMBER 1, 2022
MUST BE PAID BY DECEMBER 31, 2022. AFTER
DECEMBER 15th, PERSONAL CHECKS WILL
NOT BE ACCEPTED ON ANY TAX BILL DUE
AT THE PENALTY AMOUNT. PAYMENTS AT
THE PENALTY AMOUNT MUST BE IN THE
FORM OF A MONEY ORDER OR CERTIFIED
BANK CHECK. CASH TRANSACTIONS ARE
LIMITED TO \$100.00 OR LESS. ANY
DELINQUENT TAXES THAT REMAIN UNPAID AS
OF DECEMBER 31, 2022 WILL BE TURNED OVER
AND PAYABLE TO THE YORK COUNTY TAX
